AN ORDINANCE OF THE OTTER ROCK WATER DISTRICT, UPDATING AND CLARIFYING CURRENT RATES, FEES AND CHARGES CONSISTENT WITH THE ADOPTED 2016-2017 BUDGET; AUTHORIZING FUTURE RATES, FEES, AND CHARGES TO BE ADJUSTED BY RESOLUTION AND DECLARING AN EMERGENCY

Annotated to show deletions and additions to the code sections being modified. Deletions are **bold lined through** and additions are **bold underlined**.

WHEREAS, the Otter Rock Water District (hereinafter "District") is a properly formed Domestic Water Supply District created under ORS Chapter 264; and

WHEREAS, the District is expressly authorized by Oregon Revised Statutes Chapter 264 to adopt regulations, rates, fees and charges concerning the provision of water service; and

WHEREAS, the District complied with the water rate notice and hearing requirements of ORS 264.312 when setting, updating, and clarifying the rates referred to and compiled in this Ordinance; and

WHEREAS, on December 13, 2016, pursuant to published notice, the District conducted and approved First Reading of Ordinance 2016-01 and continued Second Reading of the Ordinance to January 10, 2017; staff was instructed to renumber the Ordinance, make corrections, and solicit public input consistent with ORS 264.312 on current and proposed rates and charges; and

WHEREAS, on January 10, 2017, the District considered written comments and testimony provided at the time set for public hearing/comment and after due deliberation and reading of changes to the Ordinance, conducted and approved Second Reading and adopted the Ordinance as an emergency enactment;

THE OTTER ROCK WATER DISTRICT ORDAINS AS FOLLOWS:

SECTION 1. Current rates, fees and charges of the Otter Rock Water District. Subject to Section 3 below, the current rates, fees, and charges of the Otter Rock Water District as contemplated and described in the 2016-2017 adopted District budget or as otherwise provided, are hereby compiled, modified and ratified as set forth in Exhibit A attached hereto and made a part hereof by this reference.

SECTION 2. Inconsistent rates, fees and charges. Any rates, fees and charges whether previously set by Ordinance or Resolution which directly conflict with, or cannot be reconciled with, the rates, fees and charges established in accordance with ORS 264.312 and set forth in Exhibit A, shall be ineffective.

1 **SECTION 3. Resolution setting rates, fees and charges**. The rates, fees and charges set 2 forth in Exhibit A may be modified by the Otter Rock Water District by Resolution after compliance with the notice and hearing requirements of ORS 264.312. 3 4 **SECTION 4 Findings Adopted.** The findings contained in the Whereas Clauses of this 5 ordinance together with the competent substantial evidence in the record of this legislative 6 proceeding are incorporated into this section by reference as if fully set forth herein, and are 7 adopted in support of this legislative action. 8 9 10 **SECTION 5. Severability**. The sections, subsections, paragraphs and clauses of this ordinance are severable. The invalidity of one section, subsection, paragraph, 11 or clause shall not affect the validity of the remaining sections, subsections, 12 paragraphs and clauses. 13 14 **SECTION 6. Ordinance Effective Date / Emergency.** 15 Inconsistent Ordinances and Resolutions concerning rates and charges must be made 16 consistent with the rates lawfully established during the budget process and otherwise in 17 accordance with notice and hearing procedures of ORS 264.312. Accordingly, an emergency 18 is declared in order that this Ordinance may be in force and effect from and after passage by 19 the Governing Body. Notice shall be provided of the emergency enactment as provided in 20 Chapter ORS 198. 21 22 Following a motion to be read by Title only, the foregoing ordinance was distinctly read by 23 Title only in accordance with Oregon Revised Statutes on the 13th day of December, 2016 24 (First Reading). and after changes were fully read and a motion for Declaration of an 25 Emergency, the Ordinance was distinctly read by Title a second time on the 10th day of 26 January 2017(Second Reading). 27 28 29 PASSED AND ADOPTED by the Board of Commissioners of the Otter Rock Water District this 10th day of January, 2017. 30 31 32 33 **BOARD PRESIDENT** 34 35 ATTEST: 36 37 38 39 40 41
