A. Call to Order via ZOOM: The first Budget Meeting of the Otter Rock Water District Board was held on May 02, 2023 via ZOOM. The meeting convened at 6:04 pm with Commissioner Elliker presiding.

- C) Board Appointment of Budget Committee

E) Budget Committee Election of Presiding Officer for Budget Committee meetings

Commissioner Elliker nominated Joknee DeMott. There were no other nominations. Joknee DeMott was declared Presiding Officer by Acclimation.

Presiding Officer Joknee DeMott presided over the remainder of the meeting.

F) Introduction to group process

Presiding Officer DeMott introduced a method of using communication cards, white, yellow, green & red. The group discussed the availability for following meetings. The next meeting was scheduled for Monday, 5/8/23 at 6pm. The preferable length of each meeting was discussed and established at about 1.5 hours.
